General George Patton School Students Send a Big Shout Out and Thank You for Donations to Library



General George Patton School students share messages of appreciation

In January, Patton Federation of Teachers Council 133 was presented with several donations for the General George Patton School Library. Thanks to efforts lead by former Local 943 IFT Field Service Director, Deb Takehara, heartfelt and generous donations were made by their fellow "Union Siblings" totaling over \$3,000. Personal donations totally \$1,500 were made by the Illinois Federation of Teachers staff union members and administrators. North Suburban Teachers Union Local 1274 members donated \$1,000 along with a donation of a collection of brand new books for their library. Finally, our Local 943 also made a contribution of \$500.

As you may recall, this council was involved in a courageous strike in 2022 which rewarded union and community members with new district and school board leadership. This new leadership has made it a priority to restore and support programs for their students. Council 133 president, Sabrina Hawthorne, was also returned to her previous position as the school librarian. Earlier this year she took on the herculean task of restoring their school library's physical space from a storage/warehouse space to a welcoming, student-friendly library space for students and teachers.

Carl J. Megel Special Education Scholarship - Honoring AFT President Emeritus

IFT educators have a unique opportunity to help special education students pursue higher education or career training by sponsoring them for this Special Education Scholarship.

The IFT will award one \$20,000 Megel scholarship (\$5,000 each year for four years) to a deserving high school senior who is enrolled in a special education school, class, or program for students with disabilities. Applicants must be high school seniors who will graduate in 2023.

IFT members who work directly with (or previously worked with) an eligible student must provide a letter of sponsorship for the applicant. (Children of IFT members may also apply)

Robert G. Porter Scholarship - Honoring late AFT Secretary-Treasurer

The IFT shall provide annually two \$20,000 scholarship awards (\$5,000 each year for four years) to current high school seniors with no less than a cumulative "B" grade average.

An applicant must be the son or daughter of a currently employed, active member in good standing of the Illinois Federation of Teachers, of IFT retirees chapter, or of a deceased member in good standing with the Illinois Federation of Teachers at the time of death.

AFT Robert G. Porter Scholars Program -

This AFT Program offers four 4-year, \$8,000 post-secondary scholarships to students who are dependents of AFT members, as well as 10 one-time \$1,000 grants to AFT members to assist with their continuing education and/or fund their proposed ideas to strengthen and grow their union. Application deadline is March 31. All scholarship winners will be notified by June 30

Each year the Southwest Suburban Federation of Teachers, AFT Local 943, awards two scholarships in the amount of two-thousand dollars (\$2.000.00) each

The applicant must be the child of a currently employed, active member in good standing of Local 943; or the child of a member of Local 943's retiree chapter; or the child of a deceased member who was in good standing at the time of death.

The applicant must be a member of a public high school graduation class and enrolling in a public college or university (including community colleges).

<u>Selection will be made on the basis of five criteria listed below:</u>
1. official scores on the ACT/SAT entrance examinations

- 2. class rank, and GPA (1st semester of senior year)
- 3. record of extra-curricular activities and community service
- 4. two (2) references by members of the staff of the student's high school where he/she is currently enrolled
- 5. a 100-word essay which details future aspirations.

I'd also like to thank everyone for your assistance with the ratification of the amended Local 943 Constitution on 12/15/22. It was a long, arduous task, but we were thrilled that EVERY council was represented and returned their ballots! The overwhelming ratification results from our member were as follows: YES Votes = 1229; NO Votes = 455.

The officers of Local 943 worked in conjunction with IFT and AFT attorneys to ensure that our new constitutional language and format was in compliance and up-to-date with best practices. Prior to voting, a copy of the revised constitution and a <u>summary document</u> explaining the new language was provided to all members. Members were also afforded the opportunity to reach out to Local 943 officers with their questions and for an explanation of rationale for the changes before casting their votes. One of the newest additions to the amended constitution was the addition of language regarding the Local 943 Retiree Council. The previous contract had no mention and no provisions for this group. Stop Penalizing Our Teachers and Public Employees! Repeal WEP and GPO - H.R.82 Social Security \Fairness Act of 2023

Everyone deserves a secure retirement, especially those who have devoted their career to public service. The Windfall Elimination Provision (WEP) and Government Pension Offset (GPO) threaten that security by substantially reducing or eliminating the EARNED social security benefits of the millions of retired teachers and public employees who contributed to Social Security through other employment. Thousands more are penalized every year as they retire from public service because their state, municipality, or school district does not participate in the Social Security system.

This unfair penalty also contributes to the current teacher and educator shortages, as it serves as a disincentive for those looking to join the ranks of teachers as a second career when they learn that the WEP-GPO penalty will jeopardize their earned Social Security benefits if they enter the classroom.

HR 82 has been reintroduced in the 118th Congress by Rep. Abigail Spanberger and Rep. Garret Graves. Representatives will need to sign on again to support this bill in the 118th Congress. So far Illinois has eleven legislative cosponsors, ten democrats and one republican, who support this repeal.

We'd like to send our appreciation to representatives Sean Casten, Kelly Robin, Mike Bost, Lauren Underwood, Janice Schakowsky, Raja Krishnamoorthi, Nikki Budzinski, Bill Foster, Jesus "Chuy" Garcia, Eric Sorensen, and Delia Ramirez for their support as cosponsors of the WEP/GPO repeal.

Retiree's Corner Protest of Orland Retiree Insurance Discontinuation

Until about 2018, when certified and support staff retired from Orland District 135, they were offered insurance from the district if the staff paid the premiums. They were told they could continue in the plan until they died or did not pay the premiums. In December 2022, they each received a letter discontinuing the life insurance as of December 2022. These retirees with the help of Local 943 staff and IFT legal assistance are protesting this action. A group of more than 90 retired support and certified staff and administrators attended the January school board meeting and spoke to the agreement that is being broken by the district. As of February 1, they continue to wait for a response from the school board and the district.

New Senators

The new AFT Local 943 constitution requires the Local 943 Retirees Council to have only three senators. Council president Kathy Setlak, vice president Sue Mirabella, and Donna Rehm will continue as senators. Many thanks to Nancy Tauchman, Laura Creighton, and Maureen Fournier for agreeing to step down and for their service and dedication to the union.
